ESSENTIAL JOB RESPONSIBILITIES/DUTIES:

1. Shall provide and utilize instructional plans, strategies, methods, materials, and techniques that best meet the needs of individual students.
2. Shall provide the leadership and direction of classroom assistants working with students.
3. Shall be responsible for the maintenance, disciplinary and instructional activities in the classroom and other school settings.
4. Shall write and participate in IEPT meetings.
5. Shall develop and maintain relationships with community agencies.
6. Must be able to communicate effectively with parents, teachers, and school administrators.
7. Must be able to work well with others as a team member in a work team environment.
8. Must have excellent oral and written communication skills.

Demonstrate emotional stability and physical stamina necessary to meet the requirements of the position to: (a) lift up to 50 pounds (b) lift, transfer and move special education students ages 0-26 years of age, (c) meet individual student health care needs, including catheterization, toileting, tube feeding, etc., (d) physical movement (up and down or working on knees).
